5. Society Report

The 2020/2021 Editor-in-Chief of the Sheaf, Carlo Narag spoke to how things went this year and how COVID impacted the production of the Sheaf.

Carlo began the year with 3 goals in mind:

- #1. To ensure the safety of the staff.
- #2. To ensure an easy transition from in-person office working to online working. This goal was especially difficult. Slack played a pivotal role for innovative communication for staff and volunteers. Trello was important for the workflow of each week. Akshara and Nicholas were two photo volunteers that transitioned easily and took on extra responsibilities for photo features.
- #3. To ensure the staff was supplied with safe and healthy skills. Initially to reduce the stress on the staff, the number of articles per section head was dropped from 4 per week to 3 per week. The weekly Saturday pitch meetings also created a space for volunteers to participate in a larger role.

NASH was held virtually this year and because of this a large number of volunteers were able to participate/attend in addition to all staff members. It proved to be a great training ground for all future staff and volunteers.

The new contributing reporter pilot project has increased volunteer engagement and resulted in numerous article pitches, taking the pressure off section editors.
